## Contest Rules

### 1. Eligibility

Singing In The Sun at Myrtle Beach Car Giveaway (the "Contest") is open to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Employees of companies, performing artists and exhibitors associated with the promotion of the Contest, and their respective parents, subsidiaries, affiliates and advertising and promotion agencies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Contest is subject to federal, state, and local laws and regulations.

### 2. Sponsor

### 5. How to Enter

On-Site: This method of entry will be available at the exhibit hall, the common lobby area, the box office and the main concert hall of the Myrtle Beach Convention Center. Limit one (1) entry per person, per email address, and per household for the duration of the Contest Period, regardless of method of entry. Entries received from any person, or household in excess of the stated limitation will be void. All entries become the property of Sponsor and will not be acknowledged or returned.

### 6. Prize Drawing

On or about April 21, 2018 at the end of the concert, the Sponsor will select a winner in a random drawing from among all eligible entries received. The odds of being selected depend on the number of entries received. THE HOLDER OF THE WINNING ENTRY MUST BE PRESENT AT THE TIME OF THE DRAWING TO WIN.

### 7. Winner Notification

The winner will be announced at the conclusion of the concert and the winner must be present at the time of the drawing.

## **9. Winning Entrant's Responsibility**
