

Contest Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

1. Eligibility

Singing In The Sun at Myrtle Beach Car Giveaway (the "Contest") is open to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Employees of companies, performing artists and exhibitors associated with the promotion of the Contest, and their respective parents, subsidiaries, affiliates and advertising and promotion agencies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Contest is subject to federal, state, and local laws and regulations.

2. Sponsor

The Contest is sponsored by Abraham Productions, Inc., Wilmington, North Carolina.

3. Agreement to Official Rules

Participation in the Contest constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. Winning a prize is contingent upon being compliant with these Official Rules and fulfilling all other requirements set forth herein.

4. Contest Period

The Contest begins on April 1, 2023 at 2:00 pm and concludes at the conclusion of the concert (the "Contest Period"). Entries that are submitted before or after the Contest Period will be disqualified. Submissions will be accepted for the duration of the Contest using any of the following methods: in person at the Myrtle Beach Convention Center or by mail pursuant to the specific requirements of paragraph 5 below.

5. How to Enter

On-Site: This method of entry will be available at the exhibit hall, the common lobby area, the box office and the main concert hall of the Myrtle Beach Convention Center. Limit one (1) entry per day, per person, per email address, and per household for the duration of the Contest Period, regardless of method of entry. Entries received from any person, or household in excess of the stated limitation will be void. All entries become the property of Sponsor and will not be acknowledged or returned.

By Mail: Mail a 3x5 index card to Abraham Productions, Inc., PO Box 15969, Wilmington, NC 28408. The index card must contain the entrant's name, full mailing address, telephone number and email address. **All mailed entries must be post marked no later than April 14, 2023. Any entry not properly marked or entry received that does not contain all required information will be considered invalid and not included in the contest.**

6. Prize Drawing

On or about April 28, 2023 at the end of the concert, the Sponsor will select a winner in a random drawing from among all eligible entries received. The odds of being selected depend on the number of entries received. **THE HOLDER OF THE WINNING ENTRY MUST BE PRESENT AT THE TIME OF THE DRAWING TO WIN.**

7. Winner Notification

The winner will be announced at the conclusion of the concert and the winner must be present at the time of the drawing.

8. Prize

The specific brand, make and model of the vehicle to be given away will be determined by availability at the time of the contest drawing. The car given away will be in the compact car classification such as Toyota Corolla, Honda Civic, Nissan Sentra or comparable, solely within the discretion of the Contest sponsor. The winner shall also have the option to opting for a cash prize of \$15,000.00. If the winner opts for the cash prize, payment of the \$15,000.00 cash prize shall be in one lump sum payment directly to the winner.

9. Winning Entrant's Responsibility

The winning entrant shall be responsible for arranging pickup of the car from the dealership. The winning entrant shall also be responsible for all licensing, registration, insurance, sales taxes, dealer prep and transportation charges, if any. All federal and state taxes that entrant may incur as a result of winning the contest shall be the sole responsibility of entrant. The winning entrant shall also be responsible for providing to Sponsor an address and social security number for IRS reporting purposes. Winner shall be responsible for any income taxes, both state and federal, attributable to the contest prize

10. General Conditions

In the event that the operation, security, or administration of the Contest is impaired in any way for any reason, including, but not limited to fraud, virus, bug, worm, unauthorized human intervention or other technical problem, or in the event the Contest

is unable to run as planned for any other reason, as determined by Sponsor in its sole discretion, the Sponsor may, in its sole discretion, terminate the Contest.

11. Release and Limitations of Liability

By participating in the Contest, entrants agree to release and hold harmless the Sponsor, and each of their respective parents, subsidiaries, affiliates, advertising and promotion agencies, other companies associated with the Contest, and each of their respective officers, directors, employees, shareholders, representatives, and agents (the Released Parties) from and against any claim or cause of action arising out of participation in the Contest or receipt or use of the prize (including any travel or activity related thereto), including, but not limited to: (a) unauthorized human intervention in the Contest; (b) mechanical, network, electronic, computer, human, printing or typographical errors; (c) any other errors or problems in connection with the Contest, including, without limitation, errors that may occur in the administration of the Contest, the announcement of the winner, the cancellation or postponement of the event or in any Contest-related materials; or (d) injury, death, losses or damages of any kind, to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Contest or acceptance, receipt or misuse of the prize (including any travel or activity related thereto). Entrant further agrees that in any cause of action, the Released Parties liability will be limited to the cost of entering and participating in the Contest, and in no event shall the entrant be entitled to receive attorney's fees. Released Parties are also not responsible for any incorrect or inaccurate information, whether caused by site users, tampering, hacking, or by any equipment or programming associated with or utilized in the Contest. Entrant waives the right to claim any damages whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages.

12. Disputes

Except where prohibited, each entrant agrees that any and all disputes, claims and causes of action arising out of, or connected with, the Contest or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in North Carolina. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, entrant's rights and obligations, or the rights and obligations of the Sponsor in connection with the Contest, shall be governed by, and construed in accordance with, the laws of North Carolina, without giving effect to any choice of law or conflict of law rules, which would cause the application of the laws of any jurisdiction other than North Carolina.

13. Privacy

Information collected from entrant is subject to sponsor's privacy policy. Each entrant consents to be included in future mailings, emails and telephone calls regarding future sponsor events.
